- I, Shri Dr. ANDREW H.VANLALDIKA, MCS, Deputy Commissioner, Lawngtlai District do hereby declared following geographical area Borkolok Village Council as Containment Zone for all the purpose and objectives prescribed in the protocol of Covid-19 to prevent its spread in the adjoining areas.
  - The Authorized Medical Team shall closely monitor the said area.
  - 2) No person without prescribed certificate shall leave the village.
  - 3) No person shall enter the area without permission.
  - 4) Supply of essential commodities shall be regulated by VLTF, Borkolok with strict adherence to SOP.
  - No vehicle shall stop within Borkolok Village Council excluding vehicle used by Medical Personnel and Official on Covid-19 duty.
