**ORDER**

In view of the recent development regarding discovery of many Covid positive in Kamalanagar area, and whereas speedy Contact Tracing and testing of Primary Contact and Secondary Contact is necessary to contain further outbreak of Covid-19 within Kamalanagar and surrounding area and after obtaining medical advice on the matter;

Now, therefore, I, Dr. ANDREW H.VANLALDIKA, MCS, District Magistrate, Lawngtlai District do hereby declared the whole Kamalanagar town area including Bajeisora, Baganpara, Arotinagar, Saizawh West and Nalbonya as Containment Zone for the purpose of Contact Tracing for the period w.e.f 23/04/2021 5:00PM to 26/04/2021 5:00AM.

**Within this period, it is hereby ordered that:-**

- 1) No person shall leave their house/courtyard.
- 2) All shop, restaurant, tea stall and main vegetable market shall remain closed.
- 3) No Maxi Cab service including Private vehicle without Covid Negative Certificate.
- 4) Even after 26/04/2021, no vehicle shall leave Chawngte without permission from competent Authority.
- 5) It is also hereby ordered that SOP laid down for management of Containment Zone shall be strictly observed.

**This order shall not applicable to:**

- 1) Magistrate, Police on duty and VLTF on duty.
- 2) Health services and Veterinary services.
- 3) Water suppliers and PHE staff.
- 4) P&E staff on duty.
- 5) Person having special permission issued by competent Authority.
- 6) Tea stalls, restaurants are allowed to make home delivery.
- 7) Every VLTF shall arrange vegetable market in their respective area.
- 8) Medical emergency.
- 9) Medicines and Groceries store.

Violation of this order shall entail punishment under Section 188 IPC.
