ORDER

Whereas the number of new cases of COVID accelerating dramatically across the Chawngte Sub-Division area is a pressing concern for the general public, as this is considered a characteristic manifestation of community transmission;

And whereas, the criticality of preventing further transmission of the virus becomes a forefront issue, and that there is an undeniable need for consistency in the application and implementation of various measures across the sub-division area;

Now, therefore, I, Dr. MANESIA KHAIMEICHHO, SUB-DIVISIONAL MAGISTRATE, CHAWNGTE in exercise of power conferred upon me under section 144 Cr.Pc 1973 (Act 1 of 1974) do hereby order that:-

- Movement of individuals shall remain strictly prohibited. Further, any person possessing a
 permit issued by the competent authority and cultivators endorsed by VLTF shall be
 exempted.
- 2. Drivers are requested to decontaminate and sanitize their vehicles frequently and ensure availability of hand sanitizers in vehicles.
- 3. All persons shall comply with safety regulations/guidelines issued by the Govt. of Mizoram.
- 4. Any gathering such as social, cultural, political, religious, academic, sports, conference and family mass gathering (excluding funeral) is impermissible.
- 5. Any person who plans to leave Chawngte Sub-Division area shall obtain Covid-19 negative certificate duly signed by authorized Medical Officer beforehand.
- 6. Any person found violating lockdown norms shall be fined directly by VLTF/Police.
- 7. VLTF concerned shall monitor and maintain a record of people's movement within their respective areas.
- 8. In the light of recent positive case discovered at banks in Chawngte, bank managers are directed to avoid crowding of people on the bank premises. In this regard, banking services such as withdrawals and deposits shall be conducted through VLTF Chairman by means of authorization letter.

This order shall remain in force with effect from 19th May, 2021 and until further notice. Contravention of this order will result in punishment under Section 188 of Indian Penal Code.
