TENDER NOTICE

With the approval of the Deputy Commissioner, Lawngtlai & Caretaker, CADC, sealed tenders are invited to grant the license for temporary collection of sand from the various approved sites (i.e. Parva-I, Parva-IV, Kamtuli, Devasora 'S', Semeisury, Betbonnya, Longpuighat-I, Longpuighat-II, Borkalak and Devasora 'N') for the period of three years. Interested parties may collect the tender form from the DCCF office within office hours.

The details of tender process are as below;

TERMS AND CONDITIONS

The terms and conditions proposed for the tender process are as follows:

1. Tender form should be collected from the office of the DCCF after depositing Rs.300 which is non-refundable.
2. The minimum bid amount will be Rs.1,20,000/-.
3. 10% of the minimum bid amount shall be the earnest money which is to be paid at the time of submission of tender form to the concerned authority.
4. The highest bid for each temporary collection site of sand shall be accepted as the successful bid and the license would be granted to the bidder for the period of three years.
5. No tender form shall be accepted after the given period.
6. Tender form should be compulsory supported by income certificate, financial soundness certificate and ST certificate.
7. The area earmarked for auction is open for inspection if the bidders so desire before the submission of the bids. For this he/she needs to contact the respective Range Officer within whose jurisdiction the area falls.

8. Department shall not be responsible for the approach road for any temporary collection of sand. Any complication in it should be sorted out by the successful bidders.
9. No subletting of license shall be allowed.
10. Furnishing of any wrong information or documents shall be liable to the cancellation of license and the amount paid will be forfeited.
11. Successful bidders shall deposit full bid amount at the DCCF office within 7 days from the issue of the acceptance order. Failing of which, his/her tender acceptance shall be cancelled without any notice thereof and earnest money will be forfeited.
12. He/she should be a domicile of CADC.
13. He/she should not be employed in any government or other public sector undertaking.
14. He/she shall not operate the temporary collection of sand after expiry of his/her license.
15. License holder has to maintain the sale proceed register.
16. The successful tenderer, after obtaining the license from the DCCF shall print and issue challan of the produce which will be carried by the driver of the vehicle. This is necessary to avoid illegal operation in the collection site, the license of the defaulter shall be cancelled and the bid amount shall be forfeited, if found violating the norms.
17. The DCCF shall reserve the right to stop the operation of collection of sand at a particular site upon proper inspection of the magnitude of environmental damages by the competent authority, if it deems its continued operation is not feasible in the future.
