With the approval of the Deputy Commissioner, Lawngtlai & Caretaker, CADC, Sealed tenders are hereby invited by the Forest Department for granting a permit for the collection, harvesting and trade of broom grass (*Thysanolaena maxima*) from CADC forest areas for the upcoming collection season. The minimum bid amount is eight lakhs. Interested individuals may collect the tender form from the DCCF office within office hours.


Tender Details:

Item: Broom Grass (*Thysanolaena maxima*)
Area/Location: Only naturally grown broom grass within CADC forest area, excluding registered private broom grass garden.
Tenure: 6 months from the date of the acceptance order.
Tender form cost: Rs 300/- only which is non-refundable.
Earnest Money Deposit (EMD): 10% of the minimum bid amount.

Terms and Conditions

- Only the authorized collector having a valid permit will be allowed to collect/buy broom grass.
- Collected broom grass must be transported with a valid Transit Pass.
- Bidders must comply with the regulations of the Forest Department.
- The highest eligible bid will be awarded the permit, subject to scrutiny and approval.
- The department reserves the right to accept or reject any or all bids without assigning any reasons.
- No tender form shall be accepted after the given period.
- Tender form should be compulsory supported by income certificate, financial soundness certificate and ST certificate.
- Furnishing of any wrong information or documents shall be liable to the cancellation of permit and the amount paid will be forfeited.
- Successful bidders shall deposit full bid amount at the DCCF office within 7 days from the issue of the acceptance order. Failing of which, his/her tender acceptance shall be cancelled without any notice thereof and earnest money will be forfeited.
- He/she should be a domicile of CADC.
