**NOTIFICATION**

**Dated Aizawl, the 12<sup>th</sup> January, 2026**

**No. A.43016/3/2023-DC&MA (C)** : Whereas all functions or powers vested in or exercisable by the Chakma Autonomous District Council was assumed by the Hon'ble Governor for a period of 6 (six) months on 07.07.2025 vide Notification No. A.43016/3/2023-DC&MA (C) dt 07.07.2025.

And whereas upon the completion of those 6 (six) months, Shri Lakkhan Chakma staked claim to be the third CEM of the 11<sup>th</sup> CADC.

And whereas, opinion of the Council of Ministers was obtained as mandated by Para 20BB of the Sixth Schedule, to which the Council of Ministers advised the Hon'ble Governor to afford an opportunity to the claimant to prove his majority, and further observed that there has been no political instability in the last six months, as the same party has continued to claim the majority.

And whereas, the Hon'ble Governor is of the opinion that, pending the submission of Report by the Inquiry Commission, and also owing to the frequent shifting of political allegiance by the elected Member of District Councils in the CADC warrant further extension of Governor's Rule.

Now, therefore, in exercise of the power conferred by Para 16(2) read with Para 20 BB of the Sixth Schedule to the Constitution of India, the Governor of Mizoram is pleased to extend his assumption of all functions or powers vested in or exercisable by the Chakma Autonomous District Council for another period of 6 (six) months or until further order. Further, the Governor of Mizoram is pleased to declare that such functions or powers shall be exercised by the Deputy Commissioner, Lawngtlai District on his behalf with effect from 07.01.2026.
