OFFICE MEMORANDUM

Whereas, it has come to the knowledge of the Deputy Commissioner, Lawngtlai that the CDCEA and CDCTA have called an indefinite pen down strike with effect from 02/04/2026 to press for their grievances due to non-receipt of employees' salaries for the last four and half months following a decision taken in the joint meeting of the associations.

Whereas, the authority would like to place on record that proposal for salary under 1st Quarter 2026-2027 including the previous balance fund has already been submitted to the Government of Mizoram which is under consideration of the Government for release of fund in respect of CADC

Whereas, the General Administration & Control Department issued an OM regarding punctuality in attendance vide No. F.23016/14/2025/CADC(G)/106, Dt. 20/01/2026.

And whereas, the authority of CADC views with utmost seriousness on the decision of the said service associations of CADC resorting to indefinite pen down protest by offices and institutions under CADC to press for their demand. As per rules 7 of the CCS (Conduct) Rules, 1964, participation of government servant in strikes is prohibited and such action on the part of the employees amount to misconduct and violation of the provision of CCS (Conduct) Rules, 1964.

Therefore, it is ordered that no employees should indulge in such activities and perform their office duties as usual. Failing which the competent authority will be constrained to take disciplinary action against the defaulting employees. All heads of the Departments of CADC shall bring the content of this office memorandum to the notice of their subordinate officers and staff including teaching staff for strict compliance.


