No. A. 43016/3/2018-DC&MA (C)/Pt : In exercise of the powers conferred under sub-rule (3) of Rule 22 of the Chakma Autonomous District Council (Constitution, Conduct of Business, etc.) Rules, 2002 as amended from time to time and in pursuance of the minutes of the meeting of the Chakma Democratic Alliance Legislature Party, Chakma Autonomous District Council held on 23.06.2026, the Governor of Mizoram is pleased to appoint **Shri Nirupam Chakma**, an elected MDC of 6-Kamalanagar South MDC Constituency and Leader of Chakma Democratic Alliance Legislature Party as Chief Executive Member of the 11th Chakma Autonomous District Council with effect from 03.07.2026 i.e. from the date of approval of His Excellency, the Governor of Mizoram.

And as desired by the Hon'ble Governor, the Chief Executive Member shall prove his majority on the floor of the District Council within 7 (seven) days from the date of his appointment.

Consequently, as per decision of the Hon'ble Governor, Governor's Rule in the Chakma Autonomous District Council shall stand withdrawn with effect from the date on which Shri Nirupam Chakma assumes office as the Chief Executive Member.
