NOTIFICATION

It is hereby notified for information of all Government and Private Schools affiliated to the **District School Education Board (DSEB), CADC**, that the proposal for conducting **Common Question Examinations for Classes III, V, VI and VII** from the Academic Session **2026-2027** could not be materialised.

In this regard, as per the direction of the **Middle School Education Department, CADC**, vide Letter No. **A.45011/02/2026-CDC(MSED)/52** dated **18th August, 2026**, and pursuant to the approval of the **Executive Committee, CADC**, in its **20th Meeting held on 10th and 11th August, 2026**, it has been decided that the proposed Common Question Examination for Classes **III, V, VI and VII** shall be conducted **from the Academic Session 2027-2028 onwards**.

Accordingly, all Government and Private Schools affiliated to DSEB are hereby directed to:

1. **Follow the syllabus prescribed by DSEB** for the respective classes strictly from the Academic Session 2027-2028 onwards;
2. Ensure that the teaching-learning process and academic activities are carried out in accordance with the **syllabus, academic guidelines, instructions and directions issued by DSEB** from time to time;
3. Make necessary academic and administrative preparations for the implementation of the **Common Question Examination for Classes III, V, VI and VII from the Academic Session 2027-2028**; and
4. Extend their **full cooperation and positive participation** in the Common Question Examination and comply with all examination rules, guidelines, schedules and other instructions that may subsequently be issued by DSEB.

All Heads of Government and Private Schools affiliated to DSEB are therefore directed to take note of the above decision and ensure strict compliance with the prescribed syllabus and academic guidelines.

This Notification supersedes all previous notifications, orders, instructions or communications issued by DSEB in this matter,
