With the approval of the Executive Committee, Chakma Autonomous District Council, sealed tenders are hereby invited from eligible bidders for the grant of permit for collection, harvesting, and trade of broom grass (*Thysanolaena maxima*) from the forest areas of Chakma Autonomous District Council for the collection season 2026-27.

Tender Details:

Item	: Broom grass (<i>Thysanolaena maxima</i>).
Area/Location	: Only naturally grown broom grass within CADC forest area, excluding registered private broom grass garden.
Tenure	: 3 rd September, 2026 to 2 nd September, 2027.
Minimum bid amount	: Rs. 35 lakhs.
Earnest money deposit (EMD)	: Rs. 5 lakhs.
Tender form fee	: Rs.100/- only which is non-refundable.

Eligibility Criteria:

- The bidder should be a domicile of Chakma Autonomous District Council.
- The tender form must be compulsorily supported by an income certificate, financial soundness certificate and ST certificate.

Submission of Tender:

- Tenders must be submitted in sealed envelopes.
- Last date & time for submission: 23/9/2026 & 1:00 pm.

Tender opening:

The tenders will be opened on 23/9/2026 at 3:00 pm in the office of the District Council Conservator of Forest in the presence of bidders or their authorized representatives who wish to remain present.

Terms and Conditions

- The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof.
- Furnishing any false or incorrect information or documents shall render the permit liable to cancellation and the amount paid shall be liable to forfeiture.
- No tender form shall be accepted after the prescribed date and time.
- The highest bidder shall be awarded the permit, subject to scrutiny and approval by the competent authority.
- Transportation of broom grass without a valid permit or requisite documents shall be treated as illegal and shall attract appropriate legal action.
- In the event that the successful bidder cancels or withdraws from the bid after award, the EMD shall be liable to forfeiture.
- Successful bidders shall deposit full bid amount at the DCCF office within 7 (seven) days from the date of issue of the acceptance order. Failing which, his/her tender acceptance shall be cancelled without any notice thereof and earnest money deposit will be forfeited.

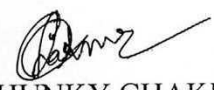
